This warranty is valid only in accordance with the conditions set forth below:

1. AB-Vanced Neu-Spine® Technologies, LLC warrants that the AB-Inforcer® will be delivered to the purchaser free of defects in materials and workmanship.
2. The AB-Inforcer® is warranted to the original purchaser for one year from the date of purchase.
3. Normal wear and tear are not covered by this warranty.
4. This warranty applies to consumer use only, and does not apply if the product is used in a commercial or institutional setting.
5. This warranty extends only to the original consumer purchaser and is not transferable.
6. This express, limited warranty is the only warranty made by AB-Vanced Neu-Spine® Technologies, LLC. Any other warranty on the product (including but not limited to any implied warranties of merchantability or fitness for a particular purpose) are expressly disclaimed except in those states, if any, that do not allow such disclaimers.
7. 1. Simply call 702-334-4327 and a customer service representative will explain how to get your AB-Inforcer® repaired or replaced and will issue a Return Authorization Number (RA) to you. No warranty repair or replacement can be made without an RA.
2. All repairs, returns or exchanges must be carefully packaged for shipment in the original boxes, and must include the following: AB-Inforcer® unit, carry bag and shoulder strap, 2 velcro straps, AC adaptor, Hand piece, and all original instructional materials.
3. All expenses of shipping, handling, and insuring the return, shall be borne by the entity returning the goods to AB-Vanced NEU-Spine® Technologies, LLC.
